Packing up, leaving early or opening late, unless approved in advance is prohibited.** While there will be an attempt made to not have multiple vendors with the same products, it is understood that exclusivity is NOT guaranteed, and that some vendors offer similar items/merchandise/services. The Township of Randolph reserves the right to cancel or close the fair due to weather or other circumstances.

Vendors must offer for sale only items appropriate for a family event. The Township of Randolph Freedom Festival Staff reserve the right to request any vendor to remove items from sale and public display any item they find objectionable or detrimental for any reason. This includes but is not limited to: fireworks, drugs, drug paraphernalia, and alcohol. The Township of Randolph and its staff reserve the right to ask a vendor to vacate its space if items are found to be unsuitable and/or the vendor is causing a disturbance to other vendors or to fair goers. All fees paid to the Kiwanis Club of Randolph, Inc. will be forfeited if this occurs.

Vendors are responsible for collecting all applicable sales tax, and obtaining any and all required permits.

Vendors must also leave their space at the end of the festival, and such space must be fully cleaned and returned to the condition it was found in.
